September 8th, 2021

Meeting called to order at 7:10; Pledge of allegiance recited.

Council Member Lindsay Edwards: Recycle bins were discussed. She would like to investigate having a similar layout as Ferron does with their dumpsters. She was requested to see of the **ATV class** for the youth who use the track out on the rodeo grounds.

Council Member Mike Christensen: Minchey's building permit has been approved.

Council Member Pat Sundstrom: CVSSD meeting on the 19th of August issued the new water fees for the upcoming year on culinary water only. He also presented the increase rates for the new minimums. The minimums were projected to increase by 25-50%. He also requested that the town to look into the minimums of water usages charges and to adjust accordingly. He talked with Garret on the secondary water use projections. The water has a window of shut off between the 1st-15th of October.

Burn Piles and Dumpsters: The council reiterated the possibility of a signage for the burn piles and dumpsters on what was appropriate for dumping and burning. Fines were also discussed and the **ordinances** that would need to passed to enforce these **new fines and disciplinary** actions required.

New Business: Cheryl Johnson's raise was discussed, a public hearing will need to be conducted to pursue such matters as an employee raise.

The Town Expansion Plan was also discussed for the future of the town for the possibilities of new families coming and building. Discussions are still ongoing. Mayor Amy Sundstrom commented on the Planning and Zoning Committee having a meeting on where to expand and when.
